

Our speaker tonight, Mr Lorenzo Riccardi, has taught taxation at Xian Jiao Tong Liverpool University, Peking University, Shanghai Jiao Tong, Tongji University and Hult Business School. He is a Tax Advisor and Certified Public Accountant specializing in international taxation at IBFD Kuala Lumpur and a PhD researcher in Asian tax at Shanghai University, Currently, Lorenzo is based in Shanghai, where he focuses on business and tax law, and specializes in Asia and emerging countries as Head of Tax of the consulting firm, RSA.

## **Brief Intro**

International taxation is the category within the field of tax law concerning domestic law and treaties that covers the taxation aspects of cross-border transactions. The purpose of international tax planning is to eliminate double taxation in an international business context, minimise the overall tax liability of a company or group of companies. International .0% tax planning try to increase after-tax profit by mitigating the effects of tax legislation. Fiscal Geography is a new concept in international tax aims to provide an introduction in the area of tax law focusing on significant national and international tax trends divided by geographical Singapore region.


